The BAC permits this requirement for the Eligibility Criteria pursuant to 2016 Revised IRR, Section 23.4.1.3, that provides:

"a) The prospective bidder should have completed at least two (2) similar contracts and the aggregate contract amounts should be equivalent to at least the percentage of the ABC as required above; b) The largest of these similar contracts must be equivalent to at least half of the percentage of the ABC as required above. For this purpose, the similar contracts mentioned under (a) and (b) above must have been completed within the period specified in the Invitation to Bid. The Procuring Entity may clarify in the Bidding Documents the definition or description of what it considers to be a similar project. (23.5.1.3a)"

Further, the BAC authorizes and consider the **online or electronic submission and receipt of bids** via BAC Secretariat official email address (bac_sg@southernleytestateu.edu.ph) provided that:

- a.) The bidder must be eligible to submit the Bidding Documents prior to its submission;
- b.) E-bid submission shall be password-protected, the bidder shall disclose the password during the schedule of the opening of bids which may be done in face-to-face through videoconferencing;

c.) A receipt is indicating that the document [hard copies in two (2) separate sealed bid envelopes: first containing the technical component and second containing the financial component of the bid with **proper tabbing**, which shall be furnished in three (3) sets] is in transit through a courier for at least three (3) calendar days before the opening of bids.
