REFERENDUM

RESOLUTION NO. 72, s. 2022

APPROVING THE RECOMMENDATION OF THE BIDS AND AWARDS COMMITTEE (BAC) TO AWARD THE CONTRACT FOR THE PROCUREMENT OF SERVICES, EQUIPMENT & OTHER MACHINERY WITH ACCESSORIES FOR THE INSTALLATION, TESTING & COMMISSIONING OF FIBER BACKBONE AND WIRELESS INTERCONNECTIVITY (SMART CAMPUS) 2ND BIDDING TO HANDLINK, INC. WITH A CONTRACT PRICE OF P21,280,000.00 AND AUTHORIZING THE UNIVERSITY PRESIDENT TO ISSUE THE NOTICE OF AWARD AND SIGN THE CONTRACT AGREEMENT

Whereas, the Bids and Awards Committee (BAC) through Resolution No. 20, s. 2022 declared HANDINK, INC. as the bidder with the Single Calculated Responsive Bid (SCRB) for the Procurement of Services, Equipment & Other Machinery with Accessories for the Installation, Testing & Commissioning of Fiber Backbone and Wireless Interconnectivity (Smart Campus) 2nd Bidding and further recommended that the contract for the said project in the amount of P21,280,000.00 be awarded to the aforementioned bidder;

Whereas, the contract amount is beyond the authority that the Governing Board granted the University President through BOR Resolution No. 84, s. 2018, thus the submission for approval by the Board of Regents;

Whereas, in view of the urgency of the need to implement the project within the second quarter of the year, the University Management has proposed to seek board approval via referendum on the BAC's recommendation;

Whereas, the proposal was submitted for review by the Board of Regents' Finance Committee (BOR-FC) on May 16, 2022, which consequently recommended that the Board approves it;

Wherefore, finding the BOR-FC's recommendation in order, the Governing Board has agreed to approve the proposal;

Now, therefore, on motion, duly seconded, and unanimously approved, be it;

Resolved, as it is hereby resolved, that the Board of Regents of Southern Leyte State University approves the recommendation of the Bids and Awards Committee (BAC) to award the contract for the Procurement of Services, Equipment & Other Machinery with Accessories for the Installation, Testing & Commissioning of Fiber Backbone and Wireless Interconnectivity (Smart Campus) 2nd Bidding with a contract price of P21,280,000.00 and authorizing the University President to issue the Notice of Award and sign the Contract Agreement.
