



BAC RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AS A RESULT OF POST- QUALIFICATION AND RECOMMENDING AWARD FOR THE PAINTING OF ADMINISTRATION BUILDING – RE-BIDDING

RESOLUTION NO. 49, S. 2025

WHEREAS, the Bids and Awards Committee (BAC) was created to ensure transparency in the procurement process and in the implementation of procurement contracts, with the end view of guaranteeing the contracts are awarded pursuant to the provisions of Republic Act 12009 and its Implementing Rules and Regulations, and that all procurement are conducted strictly according to specifications;

WHEREAS, in accordance with pertinent provisions of RA 12009, the BAC published on 31 October 2025 in the PhilGEPS, SLSU website and BAC Bulletin board the Invitation to Bid (IB) for the **Painting of Administration Building - Rebidding** under the Project No. **PB 2025-INFRA-03** with an Approved Budget for the Contract (ABC) amounting to **One Million One Hundred Twenty-Six Thousand Seven Hundred Eighty-Seven Pesos and 92/100 only (₱1,126,787.92)**;

WHEREAS, in furtherance with the provisions of the Republic Act No. 12009, representatives from the Commission on Audit (COA) as well as observers from private sector and non-government organization, were invited to observe and witness the conduct of the Pre-Bid Conference and the Submission and Opening of Bids as scheduled;

WHEREAS, on 24 November 2025, BAC passed Resolution No. 47, s. 2025 declaring the M.A.M Construction as the Lowest Calculated Bidder (LCB).

WHEREAS, upon careful examination, validation and verification of all technical and financial proposals submitted by M.A.M. Construction, BAC found their bid offers to be compliant with all the legal, technical and financial requirements, and declared as the Lowest Calculated and Responsive Bid (LCRB) with a total contract amount of **Nine Hundred Forty-Three Thousand Five Hundred Fifty-Two and 02/100 Pesos only (₱943,552.02)**

NOW, THEREFORE, with the foregoing premises considered, the undersigned members of the Bids and Awards Committee hereby **RESOLVE** as it is hereby **RESOLVED**:

1. To declare the M.A.M. Construction with the Lowest Calculated and Responsive Bid;



2. To recommend to the SLSU Board of Regents as the University 's Head of Procuring Entity (HoPE) to award the contract to the abovementioned supplier.
