



**RESOLUTION FOR THE REVOCATION OF BAC RESOLUTION NO. 09, S. 2024:
DECLARING THE LOWEST CALCULATED RESPONSIVE BID (LCRB) AS A RESULT OF
POST-QUALIFICATION AND RECOMMENDING AWARD FOR THE SUPPLY,
DELIVERY, & INSTALLATION OF VARIOUS ICT EQUIPMENT & ACCESSORIES; AND
TO RECOMMEND TO THE HEAD OF THE PROCURING ENTITY (HoPE) FOR THE
DECLARATION OF FAILURE OF BIDDING FOR FAILURE IN FOLLOWING THE
PRESCRIBED BIDDING PROCEDURES**

RESOLUTION NO. 10, S. 2024

WHEREAS, the Bids and Awards Committee (BAC) conducted an Early Procurement Activity (EPA) for the Supply, Delivery, and Installation of Various ICT Equipment and Accessories under Project/Contract No. PB 2024-G&S—EPA-02, with an Approved Budget for the Contract (ABC) of ₱4,275,618.00 via public bidding;

WHEREAS, BAC published the **Invitation to Bid (ITB)**, with Reference Number 10430156, on the PhilGEPS website on December 18, 2023;

WHEREAS, BAC conducted a hybrid **Pre-bid Conference** on December 27, 2023, at 01:30 PM at the Discussion Room, New University Library, SLSU Main Campus, Sogod, Southern Leyte. Based on the minutes of the pre-bid conference prepared by the BAC Secretariat, one question raised was: "How is the awarding? Is it one lot?" The BAC replied, "Awarding will be on a per item basis," with a notation saying, "A supplemental/bid bulletin will be posted at the earliest possible time;

WHEREAS, BAC scheduled the **submission of bids** from December 18, 2023, to before January 08, 2024, at 01:15 PM;

WHEREAS, four (4) bidders purchased the bidding documents and submitted their bids within the deadline, namely, Shift Tech Trading, Leyte Paperworld, Compuspec Sales & Services, and Electrocomputer Data System;

WHEREAS, BAC conducted the **Opening of Bids** on January 8, 2024, at 1:30 PM, and the **Abstract of Bids as Read**, dated January 8, 2024, is summarized below:

WHEREAS, BAC forwarded to the Office of the University President the **Notices to Proceed (NTP)** dated February 8, 2024, together with the supporting documents, for the signing by the University President;

WHEREAS, the University President instructed the Supervising Administrative Officer (SAO) for Administration to conduct another layer of review for the abovementioned procurement proceedings before he signs the Notice to Proceed (NTP);

WHEREAS, the review identified the following observations: (1) the Invitation to Bid and the subsequent Supplemental Bid Bulletin changing the mode of evaluation and awarding from a “per item” to a “per lot” basis was inadvertently not publicized on the PhilGEPS website and the official website of Southern Leyte State University, and it was not posted on a conspicuous place designated for public notices on the university premises for seven (7) calendar days; and (2) The minimum number of observers required under Section 13 of the 2016 RIRR of RA 9184 was not met.

WHEREAS, on March 14, 2024, the BAC conducted a meeting to address the observations, and after careful review of the documents for this procurement, the BAC discovered that there were indeed lapses in following the prescribed bidding procedures as enumerated above;

WHEREAS, given these procedural procurement lapses, it is in the best legal interest of both the University and the Lowest Calculated and Responsive Bidders (LCRB) not to push through with the Contract Agreements to avoid any issues during the post-audit of the Commission on Audit;

NOW THEREFORE, with the foregoing premises considered, the undersigned members of the Bids and Awards Committee (BAC) hereby **RESOLVE** as it is hereby **RESOLVED**:

1. To revoke BAC Resolution No. 09, s. 2024, declaring the Lowest Calculated Responsive Bid (LCRB) as a result of post-qualification and recommending award for the Supply, Delivery, & Installation of Various ICT Equipment & Accessories, and recommend to the Head of the Procuring Entity (HoPE) for the declaration of failure of bidding for failure in following the prescribed bidding procedures.
