NOTICE OF SEARCH FOR TWO PRIVATE SECTOR REPRESENTATIVES

The Board of Regents of Southern Leyte State University (SLSU) announces the **reopening of the search** for two (2) Private Sector Representatives. Applicants/ Nominees must possess the following minimum qualifications:

1. Must be a Filipino citizen;
2. Must be a baccalaureate degree holder,
3. Nominee's/Applicant's expertise/line of specialization must be relevant to SLSU'S mandate and must contribute to the strategic development of the University.
4. Must have roots in the Province or a resident of Southern Leyte, who is distinguished in his/her line of profession or field of specialization and is willing to serve for a term of two years as member of its Governing Board;
5. The Private Sector Representative (PSR) nominee/ applicant shall not, in any way, be connected with Southern Leyte State University for one (1) year immediately prior to his or her nomination as PSR;
6. He or she shall not, in any way, be presently employed or appointed to any position with any government (local, national, government-owned and controlled corporations) agency or entity, in any manner, be it full time or part time, at the time of his or her nomination/ application for the PSR position;
7. The nominee/ applicant shall be endorsed by the industry, business and professional sectors represented by his/her organizations including socio-civic groups.
8. The nominee/applicant must have not been convicted of administrative, civil, or criminal offenses.
9. Must have proven leadership, expertise and connection with the private sector; and
10. In case of serving both the government and the private sectors, at least 70% of his engagements should be in the Private Sector.
